Our committed team worked together to cover the shifts and expand responsibilities to make sure the bases were covered. We applied for a second Payroll Protection Program loan that sustained us financially. We work to advocate on behalf of children who have been physically, emotionally, or sexually abused in order to promote justice and healing for these children.

CASA | COURT APPOINTED SPECIAL ADVOCATE

📍 CHATTAHOOCHEE JUDICIAL CIRCUIT, GA & LEE COUNTY, AL

Our CASA trains community volunteers to serve as advocates for child victims of abuse and neglect. Volunteers advocate to improve a child's experience in foster care and work with the courts to ensure that each child is placed in a permanent safe home.

CHILD ADVOCACY CENTERS

Our Child Advocacy Centers (CAC) protect children by providing a state-of-the-art location for child abuse investigations. Here, child victims of suspected abuse receive care while evidence is collected in a manner that minimizes further trauma & ensures that justice can be achieved for each child. The CAC provides on-going counseling and walks with victims throughout court proceedings.

MAKING HEALING POSSIBLE

Our residential programs provide a safe and caring home for children with specific behavioral needs and challenges, and opportunities for personal growth, therapy, and development while providing necessary structure and boundaries.

ANNE ELIZABETH SHEPHERD HOME

📍 COLUMBUS, GA

The Anne Elizabeth Shepherd Home provides residential care for females, ages 10-17, who have experienced sexual trauma leading to emotional or behavioral disturbances. This program teaches the residents appropriate behaviors as they live and heal in a safe, staff-secured environment. Our on-campus school, Ault Academy, provides personalized support for academic progress.

REALITY HOUSE

📍 COLUMBUS, GA

Reality House is a teen development and step-down program for female adolescents, ages 14-21, and is designed to offer its participants the experience and opportunities needed to successfully transition from a residential environment to total independence.

"I've been at Anne Elizabeth Shepherd Home and Reality House since January 2019. Since being here, I have graduated from high school and been accepted into four colleges: Columbus State University, Albany State University, Georgia State University, and Augusta State University.

My future plans are to graduate from college with a degree in Criminal Justice and get a job in the juvenile justice system. I want to work with youth who are in the same juvenile justice system as me. I also want to be a role model for them in hopes to let them know that they can overcome their past mistakes as I did.

The staff at the Anne Elizabeth Shepherd Home had a huge impact on me. They didn't give up on me, regardless of how much I made it hard for them and how many times I made mistakes."

BRADFIELD CENTER

📍 LAGRANGE, GA

Bradfield Center provides residential services for males, 9-17, who have experienced trauma related to sexual abuse and, as a result, face behavioral challenges requiring special care. Residents live in a safe, staff-secured setting and attend school on campus at Ault Academy.

CONNECTIONS

📍 LAGRANGE, GA

Connections is designed to link residents, ages 14-21, to community, family, and resources for long-term success. This program functions as a step-down for residents who have successfully completed intensive treatment.

GEORGIA INDUSTRIAL CHILDREN'S HOME

📍 MACON, GA

GICH provides residential services for males, ages 11-18, who have experienced trauma & need a safe place to heal from the emotional effects of the trauma. The young men reside in one of five cottages on our campus, offering a structured, home-like environment. An on-site school serves residents with specific academic needs.

MAKING SECOND CHANCES POSSIBLE

Our prevention programs provide education, training, and care to youth and families in our area.

ALCOHOL & SUBSTANCE ABUSE PREVENTION PROJECT

📍 TROUP COUNTY, GA

ASAPP provides substance abuse prevention education to youth, and resources, training, and services to any community partners interested in supporting youth drug and alcohol abuse prevention.

CIRCLE OF CARE

📍 TROUP & HEARD COUNTY, GA

Circle of Care serves pregnant or parenting teens/young adults, ages 13 to 23, and their children, providing assistance to help each mother achieve self-sufficiency while ensuring the safety of her children.

DARKNESS TO LIGHT

📍 LAGRANGE, GA

Darkness to Light offers an evidence-informed, 2-hour training course called Stewards of Children, equipping adults with the training to prevent, recognize, and react responsibly to signs of child sexual abuse.

SAFE FAMILIES FOR CHILDREN

📍 LAGRANGE, GA

Safe Families for Children wraps around families experiencing a crisis and connects them to caring, compassionate community. Through many different volunteer roles, we serve families who lack social networks and live in isolation without support of family and friends.

IN 2021, SAFE FAMILIES ADDED **TWO NEW CHURCHES** TO THE SFFC NETWORK.

A mother found herself needing assistance with her children when she began to seek help for her mental health. Safe Families for Children went into action.

Two of our Host Families & Family Coaches from our local faith-based communities rallied together to support this mom and her four children.

Because our volunteers made this placement possible, the mom was able to receive the inpatient care she needed while the children were cared for in safe and loving Host Homes.

We were so excited to reunite the children with their mom and are so proud of her for taking the steps to better herself in order to better the lives of her children.

📍 OPELIKA, AL

Keeping Family Connections works with children and non-custodial parents to promote healthy bonds, increase parenting skills and end the cycle of abuse.

MAKING FAMILIES POSSIBLE

THERAPEUTIC FOSTER CARE

Therapeutic Foster Care (TFC) provides placement & care in specially trained foster homes for children with a variety of specific needs, such as emotional, behavioral, developmental or medical challenges, while equipping and supporting the foster parents to serve these children in the community.

📍 COLUMBUS, GA | LAGRANGE, GA | MACON, GA

Twin Cedars foster parents, Nate & Allie Crawford, began serving with our program in February 2017. Over the years, they served several different children, but always expressed a desire in their hearts for a baby.

On February 20, 2019, the Crawfords had their own sweet daughter, Margo. We were uncertain the family would want to manage two babies, but knew we had to call them when the referral came in for a newborn boy. Nate and Allie talked it over and said, "Yes!" They came to the hospital for training regarding the child's special feeding needs and spent hours getting to know all about this new life that would change their family forever. It began on October 29, 2019.

New big sister, Margo, quickly took a liking to baby Jude. The adorable two were "Doing great! Two little peas in a pod!" While it was not without hurdles and bumps along the road, the destination was worth the journey!

On May 24, 2021, Jude was no longer a Twin Cedars foster child. He officially became the Crawfords' son!

ENOCH MINISTRIES

📍 PINE MOUNTAIN, GA

Twin Cedars partners with Enoch Ministries, a non-profit counseling program that uses horses in sessions to help individuals, residents of group homes, military and their families who have experienced trauma, depression, anxiety, and a variety of other mental health concerns.

"I love the way the boys [from Bradfield Center] compassionately want to understand the horses and learn how to make their relationships healthier. They talk to the horses. What they say does not matter to me. It's not my business. But I see them soften as they share. They become part of the herd. It's really cool.

With the animals having the ability to except or reject them authentically, the boys have had instantaneous feedback on how they are perceived by the animals. This gives them the opportunity to change and experience the changes in their interactions due to changes in the animals' perception of them. If they feel the herd change, the boys begin to see an outside factor of a different peer's interactions. With words, they tell that peer how the herd is experiencing them. I find it very accurate, and I watch as they are being taught empathy and how to see emotional responses with a protective compassion for the animals.

I have seen many of them melt and embrace the animals as they have felt unconditional acceptance and positive regard. When they hold space for the animals and each other they get to witness anxiety decrease, fear dissipate, and trust grow."

Dear Troup County Child Advocacy Center,

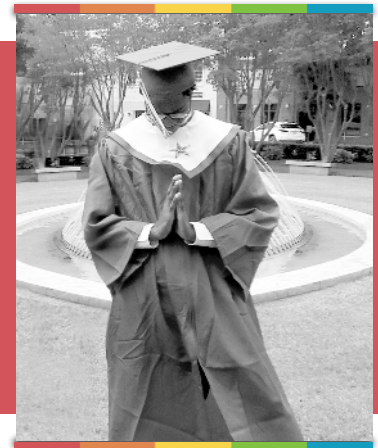
